DOCUMENTS TO BE UPLOADED BY THE APPLICANT

- Passport photo with white background
- Page of the applicant's passport with a validity period of not less than 6 months from the date of arrival in Malaysia
- Travel ticket which has been verified
- Proof of payment for accommodation
- Reference/appointment letter from a registered medical center
- Latest bank statements (3 months)
- Other relevant supporting documents

BUSINESS VISITORS

Foreign nationals who wish to enter Malaysia with the purpose of investing or attending business matter.

DOCUMENTS TO BE UPLOADED BY THE APPLICANT

- Passport photo with white background
- Page of the applicant's passport with a validity period of not less than 6 months from the date of arrival in Malaysia
- Travel ticket which has been verified
- Proof of payment for accommodation
- Latest bank statements (3 months)
- Invitation letter from a government/private agency/sponsor to invest or a business matter
- Other relevant supporting documents

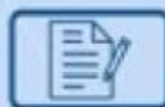


IMPLEMENTATION OF MULTIPLE ENTRY VISA (MEV) FACILITY IN MYVISA SYSTEM

Foreign nationals on a cruise from/to Malaysia boarding a cruise ship via gazetted entrance

DOCUMENTS TO BE UPLOADED BY THE APPLICANT

- Booking tickets and cruise itinerary which have been verified
- Latest bank statements (3 months)
- Proof of payment for accommodation
- Travel information
- Page of the applicant's passport with a validity period of not less than 6 months from the date of arrival in Malaysia
- Declaration of applicant or other relevant supporting documents

VISITORS FOR THE PURPOSE OF WEDDING TOURISM

Foreign nationals who intend to survey wedding venues or getting married in Malaysia

DOCUMENTS TO BE UPLOADED BY THE APPLICANT

- Passport photo with white background
- Flight tickets and itinerary which have been verified
- Latest bank statements (3 months)
- Proof of payment for accommodation
- Travel information
- Page of the applicant's passport with a validity period of not less than 6 months from the date of arrival in Malaysia
- Declaration of applicant or other relevant supporting documents
